

2026 WinShape Camps Kickoff Week Giveaway Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The **2026 WinShape Camps Kickoff Week Giveaway** Sweepstakes (“Sweepstakes”) is sponsored by WinShape Foundation, Inc., located at 5200 Buffington Road, Atlanta, GA 30349 (“Sponsor”). **The Sweepstakes is subject to all federal, state and local laws and regulations, and is void where prohibited or restricted by law. By entering the Sweepstakes, you represent that you satisfy all eligibility requirements and agree to be bound by these Official Rules. You understand that the results of the Sweepstakes, as determined by Sponsor and its agents, are final in all respects.**

THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH INSTAGRAM (THE “SOCIAL MEDIA SITE”).

SWEEPSTAKES DEADLINE: Ends at or about 11:59pmET on 3/9/26 (the “Sweepstakes Period”). Sponsor’s computer will serve as the official clock for the Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to legal residents of fifty United States and the District of Columbia, who at the time of entry are 18 years of age or older. Employees, officers, and directors of Sponsor and its affiliated companies, parents or subsidiaries, advertising and promotion agencies, distributors, agents, representatives, contractors, and any other company involved in the development or execution of the Sweepstakes (“Sweepstakes Entities”), and members of their immediate families (parent, child, sibling and their respective spouses) and same households, whether or not related are not eligible to enter or to win.

ODDS OF WINNING: Odds of winning depend on total number of eligible entries received for the prize drawing.

HOW TO ENTER: An Instagram account is required to enter. Sign into your Instagram account (or create an Instagram account if you do not already have one). Access the promotion post, follow WinShape Camps, comment on the post, and tag three other persons to enter. You may share the post to your story to enter again. Every entry must also have a Parent/Guardian who fully completes and submits his or her Camper’s camp registration forms on the Registration Site (defined below) during the Sweepstakes Period.

Camp Registration: Entrant may fully complete and submit his or her Camper’s camp registration forms by taking the following steps:

1. Create (if necessary) and log into Entrant’s account at www.winshapecamps.org (the “**Registration Site**”);
2. Go to the “Important Link” section and select “Online Medical Information”;
3. Provide complete information for all (100%) of the required sections:
 - a. Demographic information;
 - b. Emergency Contacts;
 - c. Insurance and Providers;
 - d. Diet and Activity;
 - e. Allergies;
 - f. Camper Medications;
 - g. Health History;
 - h. Immunizations;
 - i. Physical Examination Form;

- j. Authorizations;
 - k. About Me; and
 - l. Release Permission.
4. Hit Submit. Registration Site should show that Camper registration is completed at 100%.

Entry Restrictions: Comments may not contain, as determined by Sponsor, in its sole discretion, any content that is inappropriate, indecent, harmful, discriminatory or obscene; or violates any law. All comments must be in keeping with Sponsor's image and may not be offensive or violate the Social Media Site terms and conditions, as determined by Sponsor. Sponsor reserves the right, but will not be obligated, to review entries for compliance with these Official Rules. Sponsor may disqualify any entry or for any reason, as determined by Sponsor. **Limit of two entries per person.**

You must have an open or public Instagram account to participate for winner notification purposes to be eligible to win/claim a prize. If you send or receive Instagram updates from your wireless phone, your wireless service provider may charge you. Message and data rates may apply. You should consult your wireless service provider regarding pricing plans. WINNER NOTIFICATION: Potential prize winner will be notified based on information provided at entry, which may include sending a Direct Message or a message under the original entry on the Social Media Site, with instructions on how to redeem the prize.
